VIETFISH 2020 CONDITIONS, RULES AND REGULATIONS

1. SPACE CONFIRMATION

After register exhibit space and agree with booth allocation, Vietfish organizer and exhibitor will sign a contract within 10 working days. The exhibit space application is valid when the contract completed on time.

2. CANCELLATION POLICY

No cancellation by an Exhibitor is effective unless given in writing by mail, fax or email to VIETFISH Organizer, and it must be accepted by Organizer.

Exhibitors cancelling on or before February 01, 2020 shall be subject to a cancellation fee equal to 30% of the total cost of the contract.

Exhibitors cancelling on or before April 01, 2020 shall be subject to a cancellation fee equal to 50% of the total cost of the contract.

Cancellations occurring after April 01, 2020 are subject to a cancellation fee equal to 100% of the total cost of the contract.

3. IMPORTANT NOTICES

(1) **Standard shell scheme:** each 9m² or 12m² shell scheme stand including walls, carpet, fascia name (maximum 30 characters), 1 counter (0,5m x 0,7m x 1m), 1 round wood table, 6 folding chairs, 1 dust bin, 2 spot lights (1,2m, 40W-220V), 1 socket 5Amp-220V (12/24h)

(2) **Upgraded shell scheme:** each 9m² or 12 m² upgraded shell scheme stand including walls, carpet, fascia name (maximum 30 characters),

- Standing banner (2m x 0,5m) and tile banner (2m x 1,5m). The number of banner according to the number of opened side of the booth.

- 1 counter (0,5m x 0,7m x 1m), 1 round wood table, 6 folding chairs, 1 dust bin, 2 spot lights (1,2m, 40W-220V), 1 socket 5Amp-220V (12/24h).

(3) **Co-exhibitor fee** applies to Exhibitors with more than one company per booth. Price includes one basic listing in the show catalogue, badges and company name

(4) **Location fee** will be noted on the attached floor plan

Ex: The booth with 10% location fee = (99 USD/m² x 12 m²) x 1 booth x 10% = 118,8 USD
